Nordic Championships 2011, Junior Teams Conditions of Contest

As a supplement to NBU's Rules and Regulations for Junior Team Championships the following conditions of contest apply:

Each match consists of two rounds.

At the beginning of the first round the away team must seat four players at the two tables of the match. Immediately afterwards the home team must seat four players.

Line-up is completed once all eight players are seated and should be reported electronically using BridgeMate.

At the beginning of the second round any unchanged pair from the home team must be seated as in the first round. Immediately afterwards the away team must be seated observing that not two unchanged pairs are playing each other again.

Playing time for each round is 110 minutes by when the entering of all scores in BridgeMate should be completed.

No later than 10 minutes after the completion of the second round the home team must hand in the official score form, which must be properly filled in and signed by both captains.

BridgeMate is operated by North and East. North's task is to enter data, East's task is to verify the entered data. North and East share the responsibility for the correctness and timeliness of the operation equally. Warnings and penalties for BridgeMate handling failure will be awarded both sides unless the TD judges otherwise.

Failure to be seated on time will be penalized as follows:

0 - 4 minutes late: Warning
5 - 9 minutes late: -1 VP
10 - 14 minutes late: -2 VP
15 - 19 minutes late: -3 VP
20 - 24 minutes late: -4 VP
25 - 29 minutes late: -5 VP
30 minutes late: Disqualification

Failure to complete play on time will be penalized as follows:

0 - 4 minutes late: Warning
5 - 9 minutes late: -1 VP
10 - 14 minutes late: -2 VP
15 - 19 minutes late: -3 VP
20 - 24 minutes late: -5 VP
25 - 29 minutes late: -8 VP
30 minutes late: -8 VP or more at the TD's judgment

Failure to complete entering the scores in BridgeMate will be penalized in the same way as failure to complete the play on time.

Failure to hand in the score form on time will be penalized using the same scale as for failure to complete play on time. Once the captain of the away team has signed the score form he has no responsibility for the hand in. If the captain of the home team cannot find his opponent he should notify the TD and follow his instructions in order to avoid responsibility for deficient timeliness.

Appeals Committee:

Upon the need for an Appeals Committee the chief TD should set down a committee of three competent and duly qualified members chosen among players, NPCs, officials, guests or any other who the TD finds eligible.

The parties involved in the appeal will verbally present their case to the committee under the direction of a TD.

Any ruling from the committe can be appealed to the Appeals Committee of the event, which is the National Appeals Committee of the Danish Bridgefederation.
